1. ELIGIBILITY. The promotion ("Promotion") is open to people 18 years of age or older (as of May 29, 2012) residing in the 50 United States (excluding any jurisdiction where participation would be unlawful). Generally, you will need to (1) follow @logitech on Twitter; (2) take a photograph of your dad with his antiquated tech devices; (3) add an Instagram filter to your photograph and (a) tag your photo using #UPGRADEMYDAD and (b) type @logitech in the caption field (This will allow Logitech to see it on Twitter and be advised of your entry). (5) share your photo to Twitter. By uploading your photograph via Instagram, you agree to comply with the Instagram "Terms of Use" available at http://instagr.am/about/legal/terms/. Each person may submit only one entry and photo. Persons submitting more than one entry and photo may be disqualified.
