

## **LOGITECH AND BRAASI OFFER**

### **TERMS AND CONDITIONS**

**PURCHASE NECESSARY TO ENTER. OFFER VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

1. **ELIGIBILITY.** The Logitech and Prague Industries s.r.o. (dba Braasi) ("Braasi") offer (the "Offer") is open to any person of 18 years of age or older (as of date of entry) who is a legal resident of the Territory as specified in Annex 1 attached hereto (the "Participant(s)"). The officers, directors and employees of Promoter and their subsidiaries and affiliated companies and Braasi, its subsidiaries and affiliated companies, as well as all advertising and promotion agencies, persons engaged in the development, production or distribution of materials for this Offer and immediate family members or persons living in the same household (whether related or not) are not eligible to participate in this Offer. By participating in this Offer, the Participant unconditionally agrees to be bound by these Terms and Conditions.

3. **HOW TO PARTICIPATE.** Participant shall purchase one (1) Flip Folio product (the "Qualifying Device") solely and exclusively from the Logitech official website ([www.logitech.com](http://www.logitech.com)) (additional terms and conditions apply) (the "Website") in any of the following locations stated in Annex 1 (the "Territory") during the Promotion Period as defined in Annex 1 to participate in the Offer. The Participant shall receive a 35 EUR voucher (the "Gift") redeemable for a handcrafted backpack upon its purchase from the Braasi official website ([www.braasi.com](http://www.braasi.com)) (additional terms and conditions apply). The voucher will be applied through the "Add to Cart" option upon adding the Flip Folio product to the basket and will be sent via email to the Participant after the Flip Folio product has been shipped by Promoter. Vouchers will remain valid for use and redeemable during the Redemption Period as defined in Annex 1. The Participant may only claim one (1) Gift per Order (irrespective of the number of the Qualifying Device ordered) and per email address.

4. **PROMOTION PERIOD.** The promotion period is stated in Annex 1 ("Promotion Period").

5. **REDEMPTION PERIOD.** The redemption period is stated in Annex 1 ("Redemption Period").

**8. SURVIVAL.** If any clause of these Terms and Conditions should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted and the remaining clauses shall survive and remain in full force and effect.

DISPUTES.** By submitting an entry, Participant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Offer, other than the administration of the Offer, shall be resolved individually, without resort to any form of class action, and exclusively by a court
